St Mary's Parish Church Kirkintilloch Congregational Update – 12th January 2020

Once again, we are at a time when there is a lot of news to share with you. **Four key topics:**

Advent Appeal:

- Our Advent Appeal was launched with the Parishioner on 8th December 2019.
 My thanks go to the members of the Publications Committee who made this possible by collating all of the material that was enclosed with the magazine a huge task carried out diligently very much appreciated.
- We have been greatly encouraged by the response to our appeal.
 As of Sunday 5th January, 119 envelopes have been returned, corresponding to donations totalling £31,500. The vast majority of those donations also qualify for Gift Aid, which will increase the total to date to a figure in the region of £38,675.
- This is a truly wonderful response and an extremely positive message for the
 future of St Mary's. We agreed with Presbytery that we would repay our deficit
 within a period of 5 years, but we are already almost two thirds of the way
 there, after a period of only four weeks.
- Our grateful thanks go to everyone who has contributed to date.
 Contributions are still being received and we propose to continue the appeal for a period of time, to ensure that everyone is given the opportunity to participate.
- I could not have imagined a better start to our fundraising efforts, but of course
 we still have more to do. As well as reinstating our reserves policy and
 replenishing our restricted funds, we still need to reach our target of £60,000 for
 the Presbytery of Glasgow. Is this within our grasp?
- The First Challenge: If we could, during January and February, raise even 50% of what we raised in the first 4 weeks of the appeal, we would be in a position to meet our deficit in full. The significance of this is that we would be able to ask Presbytery to remove the limitation of a call on a restricted (reviewable) basis and seek a new Minister for St Mary's on an <u>unrestricted tenure</u>. This time last month, I could not have imagined being in this position. But when we consider what we have achieved in such a short period of time, it does feel like it is within our grasp.
- The Second Challenge is for us to return to the practice of meeting our Ministries & Mission contributions in full, to avoid being in the position of accumulating a deficit. To do this, we need to increase our income by around 10%, so I would ask that we all give due consideration to our level of regular giving. Gift Aid and paying by Standing Order are also both very effective ways for us to increase our income. Please speak to Hugh Biggans or John Thomson if you would like any information in this regard.

Presbytery Discussions:

- The Joint Report from the Stewardship & Finance Committee and the Vacancy Procedure Committee was presented to Presbytery as planned and unanimously approved at the meeting in December 2019.
- This means that our repayment plan has been approved and we are also granted leave to call on a restricted (reviewable) basis (until the deficit is repaid in full).
- This is an immensely positive way for us to move into the New Year my thanks go to everyone involved in getting us to this stage. Plenty of hard work lies ahead, but the building blocks are all in place to ensure we keep moving forward.

The Manse:

- We received a considerable level of interest in the Manse, allowing us to set a closing date of 13th December. At closing, we received six offers, although one was subsequently withdrawn.
- The property is currently **"under offer"**, with the offer subject to the proposed purchaser selling their own property.
- It is hoped that we will be able to conclude the sale in the coming weeks.
